11. Discussion Points

11a. Autumn annual meeting

Background: We need to set a date for the next annual meeting. We'll suggest a few dates that you can bring back to your boards.

Discussion:

David's recommended dates (for treasurers to have time to make budget revisions): latter half of november or the treasurers will need to send in the budget this sunday.

Elvira mentions that SköSex is busy every Saturday of November, as well as 24/10 due to Stormöte.

Mie suggests holding the Autumn annual meeting on a sunday

Actual pitches: 24/11 (Sunday), 1/12 (Sunday) Melissa will double check with the advisors if it's okay to hold the meeting in the beginning of december.

The chairmen will ask their boards to consider these dates, and then bring answers back next week.

11b. Sustainability week

Background: The university has asked us to hold events during the sustainability week. What's the interest?

Melissa asks if there are any questions, concerns or ideas from the board regarding this. David asks how the school "footing the bill", works. Melissa will check with the school. We'll likely send in a plan of the costs, but we want to avoid boards having to wait for the money after they've paid.

Discussion:

Mie shows the graphic (circle diagram) that gives an overview of a year of work from KS and the Student union as a whole, as a simple overview for members, students, companies etc. to get a grasp of our work.

It's been developed for the purpose of easy communication between KS.

Martin wants to help with the design (and help with the colour scheme, to make it more readable).

Alexander ponders if something other than a circle diagram may be more readable, like a horizontal "arrow". Paulina suggests something in the style of boardgames such as "När då då?".

Caroline suggests making two separate wheels; an internal "work wheel" for board members, and another one better suited for advertising publicly towards the students.

This will be published online through the Student union social media accounts.

Mie adds that they'd be good to add on our physical marketing boards as well.

11d. Sub-Associations

Background: We have gotten 3 new requests to form new sub associations. Are these topics that we want to have as sub associations? What is needed from them and us to form these associations.



Elvira mentions a lack of unifying student culture around campus, and thinks we should push this more somehow through these takeovers. Maybe switch accounts for the day between SköSex and KS.

David ponders if we can somehow develop the very basics of our branding; maybe do more than just blue and white with the crane? Maybe make it more crane-like! Buy a physical mascot? Maybe do more with the birdie?

Melissa pushes that if the marketing material is appealing, then it'll be more fun to hand over as rewards and/or buy. David also mentions that more marketing around the slogan would be good as well.

11f. Heroes of the Student Union

Background: We have put together a new tradition where at the faddertack the university will have their "buddy of the year", and the student union will have their own price to hand out to buddys who we believe have gone beyond their duties and excelled in their roles as buddies.

We will hand out a trophy to the winner. What design should the trophy have?

This year, Melissa, Mie and Caroline have selected two people that we believe have earned this.

Next week we will vote on the winners, if you have suggestions, send them in to Melissa.

Discussion:

Melissa clarifies that anyone active within the student union wouldn't be considered for this title, and David wonders how that applies to subsections, project groups like Thrills, and Skösex members? Elvira explains that Skösex has no obligation to be buddies (and naturally, their board is not eligible to win this award either.) Melissa elaborates that Framtid is too involved with KS to be eligible as well. Anton asks about Histek. They are to be treated like any other KS board. Melissa presents the current nominees for the board.

Discussions about the process for this follow. How many should earn this title every year?

Melissa and Caroline explain that there are two buddies considered for this title at the moment, as they've been truly exceptional during the intro, hence the idea for creating this award.

Paulina suggests handing out honorary memberships to the winners, to really hammer home our gratefulness, Paulina suggests.

There are discussions about having a maximum limit of winners, but it doesn't lead to a clear decision. Caroline thinks that the number of awards handed out should be based on necessity, instead of KS deciding how many should be able to be rewarded in advance. If there are three exceptional buddies one year, it shouldn't be impossible to hand out three awards, and if no buddies stand out, there should be no need to give out an award that year. This way the integrity of the award is better.

Alexander wonders why there is a need to exclude board members, as a lot of the Skösjuk buddies are active in the Student union, thus limiting the ability of the section being awarded anything.

Melissa elaborates that board members who have gone above and beyond could be considered, but the award should always be aimed towards non-Student union buddies.

Next upcoming event is the "Start Up event" where students are more than welcome to meet companies and try out pitching stuff!

Their upcoming game-jam with Volvo is their most marketed event right now, and the 2nd year to master students are the target audience, who will make games for young children to try out the following Monday after the Game jamming weekend!

This will even be marketed via the municipality, and Volvo, who's recently opened a new factory in Mariestad, are also very eager to push this.

David asks about their email, and Melissa adds it be sent out in the KS chat for the boards.


