Proposition 1: To move the programs Socialpsykologi and Folkhälsovetenskap from the section of Vitae to the section of Skösjuk.

Background:

Vitae is the only section under the Student Union in Skövde to be responsible for two institutions (IBI & IHV) for the University of Skövde. All other sections are responsible for only one institution and can therefore put more time and effort into improving the education of the institutions based on the students feedback. Being responsible for two institutions means that the Education officer of Vitae needs to attend four dialogue meetings per semester, instead of two. As well as be part of two education committees, for both IBI and IHV. This creates a bigger workload for the Education officer and we therefore want to make the workload more even between the sections.

This would also provide the opportunity for Vitae to be a more international-focused section, as it would be responsible for all international programs as well as the cognitive neuroscience programs that are partly in English. The board of Vitae would therefore be able to put our entire focus on the international students and ways to include them in the Swedish student life.

For the students under the IHV programs that are moving to Skösjuk, this would mean a bigger opportunity to be included within the student union and have a better representation within the board as well as in education matters. Vitae already focuses a lot on the international students by providing information in English as well as hosting board-meetings and events in English. This has unfortunately resulted in a lower participation rate from our national students, which is why we want to provide them the chance of participation in a Swedish-speaking section. The opportunity to be able to comfortably join events and boards that are hosted mostly in Swedish could encourage the students to participate.

Therefore the Board of Vitae wants to move the programs Socialpsykologi and Folkhälsovetenskap to SköSjuk to make them the section of the whole IHV institution. Vitae will still be responsible for the Biomedicine program, as it is similar to the other Bio-programs and shares a lot of courses with them, which are under IBI.
